

Son in the 18th of the same Reign, and was Father of another *William*, who performed the said Office in the 6th of *Henry* the 5th, and in the 7th of that Reign had Summons to serve the King in Perion, for the Defence of the Realm.

He married the Daughter of *Guy d' l' Spine*, a Person of great Account in his time, and to him succeeded *William* his Son, who was High Sherriff, in the Reign of King *Henry* the 6th, and was Father of another *William*, whose Wife was *Margery*, Daughter to Sir *John Pauncefoot*, by whom he had *Henry* his Son and Heir.

The same *Henry* married *Alice*, one of the Daughters and Co-heiress to *Thomas Baldington* of *Adderbury* in the County of *Oxford*, Esq; and by her had a Son named *William*, which *William* was Knighted, and the 5th of *Henry* the 8th, was made Sherriff of the County of *Gloucester*.

He married *Margret*, Daughter to *Thomas Thorgmorton* of *Cess-Court* in the same County, by whom he had a Son of his own Name, whose Wife was Daughter to Sir *Simon Digby* of *Colsbill* in the County of *Warwick* Knight and by her had a Son named *John* who succeeded him at *Toddington*.

He married *Elizabeth*, Daughter to *John Lord Chandois* of *Sidley*, by whom he was Father of another *John*, who was Knighted by Queen *Elizabeth*, and in the 20th of her Reign was made Sherriff of the County of *Gloucester*; after which he was Knight of the Shire for that County, and married *Anne* Daughter to Sir *Thomas Throgmorton* Knight, by whom he had another *John*, who was Knighted by King *James* the 1st, and by King *Charles* the 1st. *January* 12th. 1642. was created Baron and Viscount *Tracy* of *Rathcoole*.

He married *Anne* Daughter to Sir *Thomas Shirley* of *Isfield* in the County of *Suffex* Knight, and by her had *Robert* his Heir and Successor, which *Robert* married *Dorothy*, Daughter of Sir *Thomas Cox* of *Castleditch* in the County of *Hereford*, and had by her a Son named *William*, whose Wife was *Jane*, 3d Daughter of *Thomas Leigh*, Son of *Thomas* the 2d Lord *Leigh* of *Stonely* by *Jane* his Wife, Daughter to *Patrick Fitz-Morris*, Baron now Earl of *Kerry*, and to him succeeded *Thomas* his Son, who is now Lord Viscount *Tracy* of *Rathcoole*, and is Lord of the Mannor of *Toddington* and *Hales*, which last was an *Abby*, and founded by *Richard* Earl of *Cornwell*, King of the *Romans*.

This Lord married to his first Wife *Elizabeth*, eldest Daughter to *William Keys*, Esq; Son and Heir of Sir *William Keys* of *Eberton* in the County of *Gloucester* Baronet, by whom he has one Son nam'd *William*, and a Daughter *Jane*, and his present Wife whom he married in 1721 is *Frances* Daughter to Sir *John Packington* of *Westwood*, in the County of *Worcester* Baronet.
